RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT

In consideration of Velo Club La Grange (La Grange) permission to participate in any way in La Grange Club rides and events sponsored by La Grange, I, for myself, my personal representatives, assigns, heirs and next of kin, hereby waive and release any and all rights and claims for damages for death, personal injury, or property damage which I may have against La Grange which I may suffer for taking part in these rides or special events. I attest that I am physically fit enough to participate in these rides and events. I further acknowledge that these Club rides will be conducted on roads and facilities open to the public and upon which the hazards of the road are to be expected. I fully understand and acknowledge that cycling activities, including racing, involve risks and dangers of property damages and serious bodily injury, including permanent disability, and death.

I hereby release, discharge, and covenant not to sue La Grange, its respective administrators, directors, agents, members, volunteers and, if applicable, any sponsors, advertisers, owners and lessors of premises on which any Club ride, race, or activity takes place (collectively referred to as "Releasees" herein) from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by the negligence of the releasees, including negligent rescue operations. I further agree that if, despite this release and waiver of Liability, assumption of risk and indemnity agreement, I or anyone on my behalf, makes a claim of whatever nature against Releasees, I will indemnify and hold harmless each of the Releasees from any litigation expenses, attorneys' fees, and costs which may be incurred by reason of such a claim. I agree to accept and abide by the rules of the road and all vehicle laws. I understand that La Grange requires ANSI/SNELL approved helmets for all club rides.

I HAVE READ THIS AGREEMENT AND FULLY UNDERSTAND ITS TERMS AND UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT. I HAVE SIGNED THIS AGREEMENT FREELY AND WITHOUT ANY INDUCEMENT OR ASSURANCE OF ANY NATURE AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE EXTENT PERMITTED BY LAW. IF ANY PORTION OF THIS WAIVER AND RELEASE IS HELD TO BE INVALID, THE BALANCE OF THIS WAIVER AND RELEASE SHALL REMAIN IN FULL FORCE AND EFFECT.
