COURSE: This challenging 1.3 mile triangular circuit on the West L.A. College grounds is a course that selects the fittest to contest the finish. Half-mile descent from the start line to the first turn. The course flattens out for about 0.5 miles leading to the next left, where the road turns up (200' per lap, 0.4 mi 7% grade). The Finish and KOM line are at the top of the hill. Good pavement and room to maneuver.

REGISTRATION: Opens at 8:00 AM, and one hour before each race; closes 15 minutes prior to race time. Pre-registration must be POSTMARKED by Monday May 14th. After that add \$5. Send 2007 USA Cycling standard release form with check payable to: Velo Club La Grange, 2118 Wilshire Boulevard #525, Santa Monica, CA 90403; OR register at www.socalreg.com. Includes USCF insurance fee. Unattached riders add \$5. No unattached fees for Cat 5 men or Cat 4 women. Extra races add \$10. No refunds/credits after May 10th. Race day licensing available, USCF waiver may be signed on race day.

DIRECTIONS: Only 1 mile N.W. of 405 and 90 (Marina) Freeways. From the 405 freeway north or south, exit Jefferson and head east. Jefferson becomes Playa and then Overland. After about a mile, turn right onto Freshman Dr. into the West L.A. College campus. Follow the directions of parking coordinators to parking.

RULES: USCF Category "C" race rules apply. USCF Permit #2007-1212. Free lap rule in effect until 3 laps to go.

PRIZES: Prizes are CASH. KOMs are CASH.

Custom **WINNERS' JERSEYS** (Pro-1/2 men & women, 35+ & Cat3) Primes are cash and merchandise.

* Junior girls and boys are scored separately with separate medals.

** **Masters Cycle League (MCL):** The West L.A. College Grand Prix is the third in a series of six events for masters team competition. Team points are awarded to registered MCL teams for the series overall cash prizes (over \$1,000). Visit masterscycleleague.com for league details.

*** **Women's Cycling Challenge (WCC):** Women Cat 3/4 race (race together, score separately) is part of the 2007 WCC Series. Prizes for top 3 finishers of each category. Visit WomensCyclingChallenge.org .

Helen's Cycles KOM: On 3 designated laps in each race, the top 5 riders to the top of the climb score points (6,4,3,2,1). The 6 riders with the greatest points total win KOM prizes, which are cash.

There will also be a **TEAM COMPETITION** in each race based on the placing of the top 3 riders from each team. Make sure you bring a full squad! See www.lagrange.org for details and team prize list.
